Subject:- **State Government Scheme for Cash Incentive for passing in select Competitive Examinations conducted by the UPSC.**

No. 8/109/2012-SAT(Pt.I): It is hereby notified for general information that any domicile of Manipur who had passed the following select Competitive Examinations conducted by UPSC may avail financial benefit under a **Government Scheme** notified vide Government Order No. 11/52/2010-AR dated the 2nd July, 2012 of the Department of Personnel & Administrative Reforms (Administrative Reforms Division) Manipur. All the **eligible candidates** shall be given a sum of Rs. 1,00,000/- (*Rupees one lakh*) only as one time financial grant.

Terms and conditions of the scheme:

- A. The applicant must be a domicile of Manipur State who has -
- Cleared Civil Services (*Preliminary*) Examination or
 - Cleared Civil Services (*Mains*) Examination or
 - Been finally selected for Indian Forest Service (IFS) Examination or
 - Been undergoing/completed training for Combined Defence Services (CDS) Examination or
 - Been undergoing/completed training for National Defence Academy (NDA) Examination.
- B. The award shall be given only once to an eligible candidate/trainee/. Hence, any candidate/trainee who had previously availed this cash benefit once is not eligible to receive this benefit twice.
- The details of the scheme and prescribed format of application etc. may be downloaded from the official website www.satmanipur.nic.in
 - Any eligible candidate who is successful in any of the above stated competitive examinations may apply to the State Academy in the prescribed application format furnishing all the necessary documents mentioned herein below. No last date of submission of application has been fixed for the convenience of the candidates. However sanction of grants to the eligible candidates in a financial shall be limited to the fund available in the State Budget for that particular fiscal year. Any left out eligible candidate shall be granted the benefit in the next financial year. Hence the principle of *First Come First Serve* shall be strictly applied in granting the benefits.
 - The following documents, after duly self attested, should be enclosed in the application.
 - Copy of AADHAR or any other identification paper/document;
 - Copy of call letter/intimation letter;
 - Copy of Domicile Certificate/Permanent Resident Certificate;
 - Copy of training certificate issued by the Competent Authority of the training institute (*if the concerned training is not yet completed*);
 - Bank Account details (prescribed in Annexure II);
 - Pre-receipt of the grant (prescribed in Annexure III);
 - Undertaking (prescribed in Annexure IV);
 - Check list (prescribed in Annexure V);
