Terms and conditions of the selected trainees are:

1. All selected trainees are informed to report to the Additional Director, **State Academy of Training at 10.00 am on 27th October, 2025** along with release orders from competent authority and statement of Casual Leave Account.
2. A trainee who fails to report within 3(three) working days i.e. by 10.00 AM of 29thOctober,2025 will lose the opportunity to attend the 90th Batch of Accounts Training.
3. A trainee who fails to attain at least 80% attendance will not be permitted to appear for the Final Examination.
4. All trainees will be under the control of the Additional Director, State Academy of Training during the duration of the 90th Batch State Accounts Training. However, application for grant of Earned Leave shall be submitted to the controlling offices through the Additional Director, State Academy of Training.
5. The Pay and allowances of the trainees will continue to be borne by the respective offices/departments.
6. All trainees are informed to read and understand the revised scheme of State Accounts Training notified on 31st January, 2022 for full details of the State Accounts Training.
